Official 2019 Parade of Homes Dates: September 28-29 October 4-6 October 11-13



The 2019 Parade of Homes Committee is working hard to make sure the 54th Annual Parade of Homes is the best ever! Enclosed is the information you will need to complete your entry in the 2019 Parade of Homes. To qualify for the entry deadline you choose, your **completed entry** plus payment must be returned either via email, fax, or in person to the HBA office, 5580 Centerview Drive, Suite #115 in Raleigh before 5:00pm on the deadline date.

Be sure to review the deadline schedule carefully:

Early Bird Deadline: Wednesday, April 24th
Regular Deadline: Wednesday, May 22nd
Late Deadline: Wednesday, June 19th
Just Gotta Be Deadline: Tuesday, July 9th

If your entry is received under the Early Bird Deadline, your home may be selected to receive special emphasis in early marketing efforts. Renderings will be an upgraded **photo realistic style** in full color still using the Color Selection Sheet included in this packet.

If any changes need to be made to your entry (whether pulling the entry or switching to a different house), please review paragraph 9 of the Builder Contract carefully and notify the HBA of any entry changes immediately.

We will promote your entries to the REALTORS®, and encourage them to visit your Parade homes on the Fridays of the Parade when all the homes are open and traffic is typically the lightest.

Accurate information is essential — especially contact info, telephone numbers and e-mail addresses — so that the information in the publications is correct. **Note: most HBA communication with the Parade builders is via e-mail so be sure we have your correct e-mail address.**



- Certificate of Liability from your Insurance company (you must contact your insurance company to have them send us this paperwork)
- Provide front elevation and up to 3 floor plans electronically or on disk clean copy of original pdf straight
 from CAD. We cannot accept scanned photos, jpgs, large paper copies of original blueprints

PARADE OF HOMES BUILDER CONTRACT

Read the following **Rules and Regulations** carefully. If you can agree with and will adhere to them, and will be a <u>Builder Member</u> of the Home Builders Association of Raleigh-Wake County (HBA) as of the date of this contract and continuing through the 2019 Parade of Homes, please sign below: Note: once this signed contract is accepted by the HBA, the contract becomes binding and the home is considered an "Entry" and is subject to the rules outlined in this paperwork.

This contract is an application by the above to enter a home in the 2019 Parade of Homes to be held September 28-29, October 4-6, & 11-13, 2019. In consideration of the HBA accepting this entry and providing services in conjunction with the Parade, the Builder agrees to and is bound by the following:

Rules & Regulations

- 1. **New Home Specifications.** The home I am entering in the 2019 Parade of Homes:
 - (a) is a new home. Construction (footings poured) on this home began after July 1, 2017. A copy of the building permit will be required in case of dispute. Request for exceptions must be made in writing to the Parade Executive Committee before the entry deadline;
 - (b) has not previously been occupied and will not be occupied before or during the Parade;
 - (c) has never been in any previous Parade of Homes in order to be judged or;
 - (d) has been in the prior year's Parade of Homes, but I understand that repeat entries will not be judged;
 - (e) is located within the boundaries of **WAKE COUNTY**. Entries in surrounding counties may be accepted in the Raleigh-Wake Co Parade under certain conditions you must contact the HBA for additional steps, depending on the county. Only Wake County entries will be judged;
 - (f) will be open for the entire Parade of Homes event during ALL official Parade days and hours
 - (g) will be available to the public without admission charge during <u>ALL</u> official Parade days and hours. I, or my representative, know that we are expected to be present during <u>ALL</u> official Parade days and hours.

<u>Note</u>: For these purposes, home is defined as "House and lot in a residentially zoned area or located on a residential zoned property and situated on a permanent foundation."

I understand that a furnished "model" is subject to the same rules and regulations that apply to other Parade entries.

- 3. **Entry Materials.** To qualify for each deadline, I understand the completed entry must be submitted to the HBA office via email, fax, or in person at **5580 Centerview Drive #115, Raleigh,** by 5:00pm on the date I select. I understand that a partial submission may not be accepted or that I may be charged for the next deadline's entry rate. A complete entry includes:
 - The Entry Form, Builder Contract, Amenities & Facts Form, & Color Selection Sheet
 - Entry fee at selected level.
 - Front elevation & floor plan must be a <u>digital copy</u>. We cannot use paper copies of your blueprints. **Note: our illustrators need clean pdfs of the original copy** straight from CAD. I understand that changing elevation and floor plan after the entry has been submitted may result in a change of entry fee of \$350.
 - A copy of a Certificate of Liability from my insurance company

I understand that additional forms (Copyright Form, Certified Price Form, and Urgent Form) will be due to the HBA on their respective deadlines. Failure to provide any of the above items to the HBA by the deadlines may result in additional deadline fees and my entry being pulled from judging and the Parade.

- 4. **The HBA Provides**. For my entry fee, I understand that:
 - My Parade Home Information will be featured on www.triangleParadeofHomes.com
 - My entry will have a House Page in the Parade Book featuring elevation, up to 3 floor plans, directions and special features about my Parade home.
 - I will be given signage as outlined in the Signage Policy (bullet #12 below)
 - I will have Parade Books for distribution in my Parade home.
- 5. **Proof of House Page.** I understand that a proof of the information that will make up the House Page in the Parade Book will be <u>emailed</u> to me by the HBA. I will return the proof to the HBA <u>by the date specified with the proof</u>. If a signed proof is not returned by this date, the HBA and the Parade Committee have no obligation to contact me and any mistakes in the Parade publications are my sole responsibility and liability. I consent to the right of the Parade Committee to edit any information it deems inappropriate for publication in the Parade publications.
- 6. **Inspections**. I understand that Parade home sites may be inspected by the Parade Committee in July to determine potential for completion by show dates. If, at the time of site inspection, my site is still empty or my home is over 2,000 sq. ft. and is not in the framed and roofed stage, the Parade Committee is hereby authorized, at its discretion, to pull the home from the Parade. No refund will be given.
- 7. **Ready for Viewing**. I understand that "ready for viewing" is defined as: The exterior complete and primary "living areas" open for viewing with the front and side yards landscaped and the back yard in the final grade stage. The interior, exterior, driveways, sidewalks and garages will be safe and free from debris. I understand that the landscaping **MUST** be completed with a "finished look," to include shrubs or flowers. Plain dirt from the street to the house is not acceptable. Decorating the Parade home is strictly my decision and responsibility. I understand that my Parade house must have direct access from the street. The public must not be directed to my Parade house through a model home or sales office.

8. The Parade, a Promotional Event. I understand that:

- the Parade of Homes is a promotional event to spur the sale of new homes to the public. The event is free to the public. I also understand that communication (especially problems) with the Parade Committee and HBA staff is critical for the success of this promotional event.
- the terms "Parade of Homes," "Parade" or the Parade of Homes logo may not be used by any entity (other than the HBA) in any form of promotion such as open houses, print or media advertising, news or feature articles in the print or media, etc. without the written consent of the HBA.
- when a Parade entry is also used as a "show house" (i.e., charity event, *Southern Living, Extravaganza* house, etc.) written notification must be provided to the Parade of Homes Committee. All written, verbal and/or visual marketing promotions for the event must be approved by the Parade of Homes Committee and must state that the "show house" is a Parade entry. The Parade dates should be used. The logo may be used on any written and/or visual marketing promotions with the written consent of the Parade Committee.
- 9. **Withdrawal Deadlines**. I will notify the HBA in writing of withdrawal if my home is sold or will not meet the Ready for Viewing criteria (outlined in #7 above) by the opening time on the opening day of the Parade. Note: if house has not been started by July 9, builder must notify the HBA and the entry must be pulled from the Parade. The HBA will not order a sign for me and my entry will not appear in the Parade book. (Note: If paperwork is submitted and accepted, then it is considered a valid entry and all Parade rules apply, including withdrawal/refund rules below.)
 - Refund if house is not going to be Ready for Viewing: If I notify the HBA no later than 5:00pm on Thursday, July 11, 2019 that my home will not be complete, I understand that my home will be withdrawn from the book and the Parade, and I will receive a \$500 refund.
 - Refund if house is sold: If I notify the HBA no later than 5:00pm on Thursday July 11, 2019 that my home is sold, I understand that my home will be withdrawn from the book and the Parade, and I will receive a refund equal to 50% of my entry fee.
 - Notification after July 11, 2019. If I notify the HBA after July 11, 2019 that my home is either not complete or sold, I understand that my home will be pulled from judging but will be included in the book and the Parade, and I will not be entitled to a refund. The HBA will communicate withdrawal information to the Parade's website and mobile app.

10. Penalties. I understand that

- if my home is not ready as specified in #7 above and has not been withdrawn in writing, I may lose the privilege of entering future Parade of Homes.
- If my home is not ready for judging as specified in #12a, and I did not notify the HBA in writing before judging day, I may be subject to a \$200 fine

11. Signage Policy. I understand that

- I will be given **ONE** large 4'x4' yard sign which must be placed in the <u>front yard of my Parade home</u>. I will be given **TWO** directional signs per entry these directional signs are the **ONLY** official signs authorized for use. I understand and agree that I **MAY NOT** print my own signs utilizing the phrase "Parade of Homes" or the Parade of Homes logo. Note: For homes featured outside of Wake County, special signage may apply. Please contact the HBA.
- If I sell my home after the final Parade Book deadline in August and it will not be available for viewing or it is "not complete," I must order appropriate signage from the HBA. This signage shall be posted across the face of the 4x4 Parade sign that must be placed in the front yard of the Parade home. I agree to pay for any additional expenses incurred by the HBA for any public relations problems with my Parade home as approved by the Parade Committee.
- No 4' X 4' Parade of Homes sign may be displayed after the Early Bird deadline of the following year's Parade.
- I understand that if I use all or part of a Parade sign including logo to promote my own non-parade home during the Parade, I could be prohibited from entering future Parades

12. The Awards Competition: Judging Policies


- a) I understand that **Ready for Judging** is defined as: (1) the home must be "ready for viewing" as defined in item #7, (2) the flooring and carpeting installed, (3) final cleanup complete, and (4) the 4' X 4' yard sign placed in front of the entry. Builder will be subject to a fine of \$200 if a home is deemed not ready for judging and the builder did not notify the HBA in writing before judging day.
- b) Price certification forms are due to the HBA by Thursday, July 11, 2019. For a home to be judged, the price must be published in all publications.
- c) Prices of the homes for judging purposes must be *certified with honor*. The certified price must reflect the normal pricing methods that the Builder uses when determining fair market value. The price of the home **MUST** include the price of the lot (cannot be listed as \$0) and all amenities included in the final marketed sale price of the home. The price of the lot is separated out for the judges only as a basis for comparison.
- d) Fully furnished model homes will be listed and judged at the "as shown" price which should be the price as if the home was being marketed for sale that day. There will also be a listing of the "base" price of the home.
- e) The certified price of the home must be the same as the MLS listing. This price will be taken from the Price Certification Form. During judging and the Parade, all pricing literature including the MLS listing must match the Certified Price Form on file.
- f) If the home is sold and buyer upgrades are installed prior to judging, but after the price was certified, the cost of the upgrades must be added to the certified price. It is not relevant if the home sells for less than the certified price.
- g) Leading up to judging and during the Parade of Homes, if the entry is marketed for more than the certified price, this then could constitute "underpricing." This includes but is not limited to MLS listing, flyers for the homes and any advertising whatsoever. Such underpricing issues will be decided by the Parade of Homes Executive Committee.
- h) Homes that are sold and are not available for viewing during the Parade will not be judged.
- i) Out-of-town builders, individuals in the sale and marketing of new homes field, developers, etc. will judge the entries. The decision of the judges is final. The Parade of Homes Committee and the HBA have no influence or control in the judging.
- j) The home must be complete, open and/or staffed from 8:30am until 6pm* on September 27th. *Note: in some cases, all the homes may not be judged by 6:00pm. Homes must be left open until judging is complete. If the home is locked, it will NOT be judged.
- k) No one may be in the home during judging except the driver and the judges. If the home is not vacated upon request, the home will not be judged.
- Any Gold, Silver or Bronze winner that is not open to the public during <u>ALL</u> official days and hours of the Parade will forfeit the award and/ or the privilege of participating in future Parades may be lost for as long as one year.
- m) If an award winning entry is disqualified for any rule infraction, the builder will be responsible for reimbursing the HBA the cost of the disqualified winner plaques and signage and must return any plaques or signage to the HBA.
- 16. **Indemnification.** I do hereby certify that: The home to be placed in the 2019 Parade of Homes is the result of an original design, that I have obtained the legal rights to use the design from the copyright owner and to the design as represented in the structure, plans, specifications, and drawings for the home. I further represent that I have not pledged, assigned, or encumbered the rights to the design and that such design does not violate any copyright, property, or common-law rights of others. I hereby indemnify and hold harmless the HBA from any and all claims of third parties, including, but not limited to, copyright infringement or conversion, which may be asserted as a result of the inclusion of the home in the Parade or the inclusion of elevations or floor plans of the home in any publication of the HBA or in conjunction with the 2019 Parade of Homes.

I agree to indemnify and hold the HBA harmless from and against all claims, losses, costs, damages, expenses and liabilities for bodily injury, death, or property damage, arising out of or in connection with any and all occurrences on or about the home, caused in whole or in part by the other. I do further promise to have a liability insurance policy in effect covering the Parade Home during the time of the Parade and will provide a copy of a Certificate of Insurance to the HBA with the HBA and the Parade of Homes noted as "additional insured"

17. Acts of God. In the event that an Act of God prevents performance by the HBA or builder, that failure of performance shall not constitute a breach of this Contract.

I have read and do hereby agree to abide by the **Rules and Regulations** as set forth herein above for the 2019 Parade of Homes by the Parade Committee and the HBA. I understand that failure to comply subjects me to forfeiture of any and all privileges (including becoming ineligible to participate in future Parades), and in the event of any misunderstanding of this contract, agree to accept the decisions of the Parade of Homes Executive Committee as final.



We were advised by legal counsel to avoid potential problems of infringement by obtaining specific authorization from the plan designer to use any copyrighted materials in <u>all</u> of the Parade of Homes publications.

If you (the builder) are the plan designer, sign the form twice — once as the plan designer and again as the builder. If you are not the plan designer, please sign as the Builder, and forward the authorization form to the plan designer and ask the plan designer to sign and return the form to the HBA. This information will be included on your "House Page" in the Parade publications as follows: "House Plan Designer©: the name you supply."






